 - Read Highlights of January Minutes indicating were updates (post meeting) had been added for the Treasurer's Report and for the Spring Retreat Flyer.

- Jim suggested: name tags, Steps 1-3 (plus Steps 4-6 etc, or Steps 4-12) rather than Steps 1-12, and to add a map of Scarboro Missions property (entrance etc) so you don't get lost when you get there.

f) Fall Conference 2014 – Jody N.

- Fred suggested to get a contract from Church to fix costs etc .
- Report accepted, group conscience.

g) Correspondence received and sent (checking mailbox) – Susan O.

h) Website - Charles V.

- See Charles' report (attached)
- Some discussion about one Ontario group that lists itself as 'Open' while the Ontario IG policy is that groups should be 'Closed' (definitions are available at the FWS website). Research by several people revealed that FWS recognizes 'Open' groups and that several cities do have Open meetings. The group has been asked to clarify what they mean by an Open meeting but they have not yet responded.
- Meeting List (from last month) can be available as both Letter and Legal size (3 columns and 4 columns, respectively). Group agreed the Meeting List should be available in both formats.
- Jim asked for clarification about double side and fold comment (on the Letter size Meeting List); clarified that print both sides and tri-fold (which has always been the way it was printed).
- Accepted group conscience.

8. Old Business (Tabled from previous meetings)

a) Intergroup income this year is lower than last year. Is this a problem or not? Some data on this are as follows (values updated from previous meeting to include December contributions and 2012 value (*) corrected to remove profit from conferences):

Donated to IG the previous year (2012): \$4562* Donated by IG to FWS the previous year (2012): \$2671 Donated to IG last year (2013): \$3396 (74%) Donated to FWS last year (2013): \$1411 (53%)

- Jim asked if these decreases are important? Alternatively, is this just a random blip?
- Michael noted that membership has gone down; and others noted the same.
- Jody mentioned the 60/40 donation; more about this to be discussed later.
- For now, this decrease in donations to IG and from IG to FWS is just noted and to be watched in the future.
- b) Intergroup attendance (from intergroup reps) is not as strong as it could be is there anything we can do to encourage better involvement?
 - Just noted and nothing more.
- c) Website "Donations to Intergroup" do we need to re-visit any of this content? In October the amounts for 2010 were removed (as they were out-of-date); should we post amounts again (or just percentages of money) with the actual 2012 or 2013 values?
 - Jody is going to work with Tim and Charles to see if we can post this information.
- d) Alan suggested forming a committee to look specifically at the question: "What is the Single Purpose of SLAA" discuss further should we form a committee?
 - Obsolete; this has been discussed previously.

9. New Business
